1	What is an L-15/L-15F license?	L-15/L-15F license is a license for service of Indian and Foreign Liquor in a Hotel to residents in their rooms, granted by the Deputy Commissioner (Excise).
2	What is an L-16/L-16F license?	L-16/L-16F license is a license for service of Indian and Foreign Liquor in a bar/Restaurant attached to a Hotel, granted by the Deputy Commissioner (Excise).
3	What is an L-17/L-17F license?	L-17/L-17F license is a license for service of Indian and Foreign Liquor in independent Restaurant, granted by the Deputy Commissioner (Excise).
4	What is an L-18/L-18F license?	L-18/L-18F license is a license for service of Indian and Foreign Wine, Beer and Alcopop in independent Restaurant, granted by the Deputy Commissioner (Excise).
5	What is an L-19/L-19F license?	L-19/L-19F license is a license for Round the clock service of Indian and Foreign Liquor in independent Restaurant located either in arrival or departure area of International Airport, granted by the Deputy Commissioner (Excise).
6	What is an L-28/L-28F license?	L-28/L-28F license is a license for service of Indian and Foreign Liquor in a Club, granted by the Deputy Commissioner (Excise).
7	What is an L-29/L-29F license?	L-29/L-29F license is a license for service of Indian and Foreign Liquor at a club/Mess whose membership is exclusively for Government Servants, retired Government Servants and the club/mess is not run on commercial lines, granted by the Deputy Commissioner (Excise).
8	What is an L-6 license?	Retail vend of Indian Liquor in public sector. Currently, grant of new licenses in this category has been put on hold.
9	What is an L-6FG license?	Retail vend of Foreign Liquor in public sector to the folder of license in Form L-6. Currently, grant of new licenses in this category has been put on hold.
10	What is an L-7 license?	L-7 license is a license for Retail vend of Indian Liquor in Private Sector, granted by the Deputy Commissioner (Excise). Currently, grant of new licenses in this category has been put on hold.
11	What is an L-7FG license?	L-7FG license is a license for Retail vend of Foreign Liquor in Private Sector, granted by the Deputy Commissioner (Excise). Currently, grant of new licenses in this category has been put on hold.
12	What is an L-10 license?	L-10 license is a license for Retail vend of Indian and Foreign Liquor in shopping malls or airport, granted by the Deputy Commissioner (Excise). Currently, grant of new licenses in this category has been put on hold.
13	When one can apply for grant of L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F, L-19/L-19F, L-28/L-28F & L-29/L-29F license?	Applications for the grant of L-15/L-15F, L-16/L-16F, L-17/L-17F, L-18/L-18F, L-19/L-19F, L-28/L-28F & L-29/L-29F are invited through out the year on ESCIMS portal.
