Frequently Asked Questions on Delhi Ladli Scheme, 2008

- **Will the girls born on or after 1st January 2008, alone avail benefit under this scheme?**

Yes the Girls born on or after 1st January, 2008 but girls born before this date can also avail this scheme at the time of taking admission in the classes mentioned below and after passing out class X.

Girl should have been born on or after 1st January, 2008. Remittance at the time of birth Rs. 10,000/- (Rs.11,000/- if born in a hospital or a maternity home),

Rs.5000/- every time on taking admission in class I, VI, IX, XII. and Rs.5000/- at the time of passing class X.

Can apply separately at the time of getting admission in any of the above classes.

However income of parents, combined, should be less than Rs. One Lakh per annum.

- **Whether a girl studying in the same school, can apply in this scheme on promotion to classes mentioned above ?**

Yes. If a girl gets promoted or admitted in any of the above mentioned classes, she can apply for the other benefit under.

- **Can girls studying in a private / public school, apply for this scheme?**

Yes. But the school should be recognized by Govt./MCD/NDMC or Govt. recognized schools in Delhi and annual income of their parents should be less than Rupees One Lakh per annum.

Only those girls, whose application has been made on the basis of birth after 1st January 2008 and renewed every time while taking admission in class I,VI,IX,XII and at the time of passing class X, shall get an amount of Rs. One Lakh approximately. All other girls shall get the amount with interest of the sum deposited in their account by the Delhi Government.

- **Can girls born outside Delhi but residing in Delhi for more than 3 years be benefitted by this scheme?**

As per the notification no. F.08(1)/FAS/GCPR/DSW/06-07/2056-70 Dated 01/02/2008 only girls born in Delhi can avail benefit of this scheme, provided that they have a birth certificate issued by the Registrar (Birth & Death) of Delhi

- **Can girls born in Delhi but studying in NCR (Noida, Faridabad, Gurgaon etc.) also be benefitted by this scheme?**

No, Only girls studying in a Delhi Government Schools/ recognized schools /MCD schools/ NDMC school/ Cantonment Board schools can avail benefit under this scheme.

- **Does Ladli Scheme Form costs anything?**

The forms are being distributed free of cost These are available in the schools in the District office of Women & Child Development Department and the same is also available on the Department website www.wcddel.in and can be applied through e-district portal <https://edistrict.delhigovt.nic.in/> .

- **What is the on line procedure for applying for Ladli?**

- Application to be made online on e-District portal (Delhi)

- Any applicant who wishes to avail Ladli Scheme,2008 has to register herself on e-district portal of GNCTD.

- Under Citizen Corner click on New User
- Click on select the document – Aadhar or Voter ID
- Enter your Aadhar Card Number/Voter I Card Number
- Type the Captcha in the box shown

- **If the form is not available in the school, who should be contacted?**

The District Office of Women & Child Development GNCTD and the same are also available on the Department website www.wcddel.in and can be applied through e-district portal <https://edistrict.delhigovt.nic.in/>.

- **If the certificate from the Registrar (Births & Deaths) is not issued in time, what should be done?**

One year time is provided at the time of birth and 90 days are given at the time of getting admission in different classes for applying under this scheme. Even then, if the certificate is not received then on the basis of the application deposit receipt for issue of birth certificate this time limit can be extended further by District office of Women & Child Development Department As per the notification no. F.08(1)/FAS/GCPR/DSW/06-07/2056-70 Dated 01/02/2008.

- **If the certificate from the Registrar is not issued in the case of home delivery, what should be done?**

Birth certificate can be obtained by contacting officer of the Local Body or Zonal D.C. of MCD.

- **What should be done, if filled up form is not accepted by the school / Women & Child Development officer?**

School Principals & District Officers of Women & Child Development are directed to issue, get filled up and receive these forms and to the concerned District Office, WCD Officer in person/ or mail (list attached). Also, specific grievance can be brought to notice of Help Desk at the Head Office Deptt. Of Women & Child Development, Maharana Pratap Building, ISBT Kashmere Gate, New Delhi – 110006

- **If a girl is not able to pass class X due to any circumstances, will she still get the amount?**

As per the notification of no. F.08 (1)/FAS/GCPR/DSW/06-07/2056-70 Dated 01/02/2008 of Delhi Ladli Scheme. The deposits shall be encashable only after the child attains 18 years and has passed atleast class 10th.

- **If there are more than two girls in a family, how many of them will be benefitted by this scheme?**

Any two eligible girls of a family can be benefitted by this scheme.

- **If the girl child dies, can other girl get the amount transferred in her name?**

No.

- **Can any other person take this amount?**

No, this amount will be deposited in the girl's bank account only after she attains the age of 18 years. No other person can take this amount.

- **Many Principals refuse to give and verify Ladli Scheme forms. What should be done in such cases?**

Principals have been directed to distribute, verify/ attest, accept and issue acknowledgement slips and send the forms to the District offices of Women & Child Development / Social Welfare Department.

- **Will the form be accepted if some columns of the form are not filled?**

No, All the important information in the form i.e.name, address, annual income, number of daughters, birth certificate, photo, school and class must be given. Columns which are not applicable can be left unfilled.

- **Will the renewal after passing 12th class be done if Girl is enrolled in Ladli Scheme**

No renewal has to be done if the Girl Child passes 12th class and files the maturity claim as per order F.No.8(839)/DWCD/LADLI/2014-15/36269-280 Dated : 06/01/2015.
